\$5-6 billion per year in tax cuts to large corporations. Canada now has the lowest corporate tax rate in the G7

\$29.3 billion for stealth fighter jets
- Harper's estimate is \$16 billion over 20 years
- The Parliamentary Budget Officer's estimate is \$29.3 billion over 30 years

\$10-13 billion for mega-prisons
- first estimate by Harper government was \$89 million
- amendments to the Criminal Code an estimated **\$1 billion annually** over five years

\$1 billion for photo-op at G8/G20 summit. Harper won't reimburse Toronto businesses for damages caused by rioters at the G20 Summit

Liberal Priorities

\$1 billion to support those caring for sick loved ones at home. **\$1,350** per year to help low-and middle-income family caregivers

\$1 billion in direct financial support to families for higher education. **\$1,000** a year over four years to every college or university student. **\$1,500** a year to students in low-income families

\$400 million for green renovation Tax Credit—**\$13,500** for home improvements to help Canadians make their homes more energy efficient

\$700 million per year in Guaranteed Income Supplement benefit for low-income seniors. All seniors deserve a dignified retirement. Work to expand Canada Pension Plan to help those with no retirement plan
